Item No.1: Students Attendance:

Resolution for B.Sc. III & V: All the students will be given 100% attendance upto 18th November, 2024 for the month of November only. However, the attendance for previous months will be the same as given by the concerned Teachers. Thereafter, any student fall below 40% of the attendance will not be allowed to sit in the End Semester- III & V Examinations - Nov./Dec., 2024 (Theory & Practical Both).

Resolution for B.P.Ed I & III: All the students will be given 100% attendance upto 18th November, 2024 for the month of November only. However, the attendance for previous months will be the same as given by the concerned Teachers. Thereafter, any student fall below 64% of the attendance will not be allowed to sit in the End Semester- I & III Examinations-Nov./Dec., 2024 (Theory & Practical Both).

Resolution for M.P.Ed I & III: All the students will be given 100% attendance upto 18th November, 2024 for the month of November only. However, the attendance for previous months will be the same as given by the concerned Teachers. Thereafter, any student fall below 65% of the attendance will not be allowed to sit in the End Semester- I & III Examinations-Nov./Dec., 2024 (Theory & Practical Both).

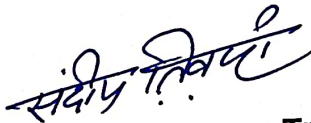
Item No.2: Fees prescribed for Students Attendance in B.P.Ed. Course:

The Staff Council authorized the Attendance Committee to send its recommendations on this matter to the Staff Council in its next meeting.

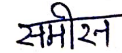
Item No.3: Any Other Item/s:
