**SELECTION OF NCC CADETS - SPECIAL ENTRY SCHEME (NAVAC)  
IN THE NAVY COURSE COMMENCING JUL 2024**

1. **Special Entry Scheme (NAVAC)** course for the Navy is due to commence at the Naval Academy, INS Zamorin, Ezhimala, Kerala in **Jul 2024**. **Six vacancies** have been reserved for NCC 'C' certificate qualified Naval wing cadets. Section 'D' of the Application forms should be duly recommended by concerned ADGs/DDGs alongwith relevant certificates/documents as per specified format (copy enclosed) are required to **reach this Dte Gen by 30 Nov 23**. Nil report is also required.

2. The eligibility criteria for entry for Special Entry Scheme (NAVAC) and the salient features are as follows:-

(a) Candidate to be **unmarried male** of age between **19 – 24 years**. Candidates born not earlier than **01 Jul 2000** and not later than **01 Jul 2005** (both days inclusive) are eligible for the above course.

(b) **Educational Qualification:-** The cadets must possess a **Degree in Engineering** from **AICTE recognised university/Institute/Marks sheet/Provisional Certificate** with **Naval Wing Senior Division 'C' Certificate**.

(c) Entry scheme is for Naval Wing Cadets of **Senior Division (SD)**.

3. Following enclosures are to be attached with the application:-

(a) Attested copy of 10th Marks Sheet & Certificate for supporting of DOB.


