



अधिसूचना

यह अधिसूचित किया जाता है कि दिल्ली विश्वविद्यालय के सक्षम प्राधिकारी द्वारा अधिसूचना संख्या Estab.II(i)/2021/51 दिनांक 6 जनवरी, 2021 और Estab.II(i)/010/2021/01/1327 दिनांक 10 जून 2021 द्वारा अनुकंपा के आधार पर नियुक्ति के लिये नियमों के निर्धारण के लिए गठित समिति ने अपनी रिपोर्ट प्रस्तुत कर दी है। समिति ने 31.12.2020 तक हुई मृत्यु/चिकित्सा अक्षमता के मामलों पर ही विचार किया। 31 दिसंबर 2020 तक रिक्त और विश्वविद्यालय द्वारा अधिसूचना संख्या Estab.IV/290/2021 दिनांक 23.02.2021 द्वारा विज्ञापित पदों तथा मृतक आश्रित को अनुकंपा के आधार पर नियुक्ति के नियम के आधार पर 48 पदों की पहचान की गयी है। उपलब्ध आंकड़ों के अनुसार, मृतक आश्रितों को अनुकंपा के आधार पर नियुक्ति के लिए 171 आवेदक पात्रता रखते थे जिन पर विचार किया गया।

समिति ने इन उम्मीदवारों से आवेदन आमंत्रित किए। आवेदन आमंत्रित करने की सूचना वेबसाइट पर भी अधिसूचित की गई थी ताकि ऊपर निर्दिष्ट समय अवधि में आने वाले अन्य पात्र आवेदक भी 17 सितंबर, 2021 तक आवेदन कर सकें। समिति ने निम्नलिखित मानदंडों के आधार पर प्राप्त आवेदनों की जांच की है:

1. कर्मचारी की मृत्यु के बाद आवेदक द्वारा प्रस्तुत किये गये पहले आवेदन को ही मूल आवेदक माना गया है। बाद में परिवर्तित आवेदक पर विचार नहीं किया गया है। नए आवेदकों को समय-बाधित मामले के रूप में माना गया है और इसलिये योग्यता अंक प्रदान नहीं किए गये हैं। हालांकि, मूल आवेदन पर पात्रता के अनुसार विचार किया गया है।
2. आवेदक की आयु, निर्भरता, शैक्षिक योग्यता आदि की पात्रता शर्तों को सामान्य नियमों जैसे पेंशन नियम, स्थापना नियम को आधार माना गया है।
3. मृतक कर्मचारी पर आवेदक की निर्भरता को विश्वविद्यालय को नियमित कर्मचारी की मृत्यु / विकलांगता की तिथि से निर्धारित किया गया है। तदनुसार, ऐसे पुत्र/पुत्री को कर्मचारी की मृत्यु/विकलांगता की तिथि पर कर्मचारी पर आश्रित होना चाहिए।
4. कार्मिक और प्रशिक्षण विभाग के दिनांक 25 फरवरी, 2015 के क्रमांक 14014/02/2012-स्था (डी) के अनुसार समिति ने विवाहित पुत्र को मृतक कर्मचारी के आश्रित परिवार के सदस्यों

की देखभाल करने के लिए मृतक कर्मचारी पर आश्रित माना है यदि मृत कर्मचारी के पति / पत्नी ने आवेदन नहीं किया है या पात्र नहीं है।

5. विधवा/तलाकशुदा पुत्रियों को जब वह मृतक कर्मचारी की मृत्यु के समय उसके परिवार की आश्रित सदस्य थी केवल तभी पात्र माना गया है। हालांकि, आज की तारीख में विवाहित पुत्री को आश्रित नहीं माना गया है।

6. ऐसे मामलों में जहां परिवार का कोई भी आश्रित सदस्य वर्तमान में मौजूद नहीं था, अर्थात्, पति या पत्नी की भी बाद में मृत्यु हो गई, और बच्चे वर्तमान में आश्रित परिवार की परिभाषा के अंतर्गत नहीं आते हैं, ऐसे मामलों पर सिफारिश के लिए विचार नहीं किया गया है।

7. ऐसे मामलों में जहां कर्मचारी की मृत्यु के समय पति/पत्नी नियमित सेवा में थे/हैं, ऐसे परिवार के सदस्यों को परिवार के आश्रित सदस्य के रूप में नहीं माना गया है।

8. यदि मृतक कर्मचारी के आश्रित पुत्र की भी मृत्यु हो गई है, तो बहू के आवेदन पर विचार नहीं किया गया है यदि पुत्र सेवा रिकॉर्ड में मृतक कर्मचारी द्वारा घोषित आश्रित परिवार का सदस्य नहीं था।

9. आवेदकों की वित्तीय अभाव का आकलन करने के लिए, समिति ने विभिन्न सरकारी विभागों जैसे डाक विभाग, आईटी मंत्रालय, सीबीआईसी की अधिसूचनाओं पर विचार करते हुए डीओपीटी के नवीनतम दिशानिर्देशों के अनुसार वेटेज पॉइंट प्रदान करने के लिए एक बिंदु आधारित मेरिट सिस्टम (पीबीएमएस) (अनुलग्नक-I) तैयार किया है।

10. 171 (उपलब्ध कार्यालय रिकॉर्ड के अनुसार, विश्वविद्यालय की वेबसाइट पर अधिसूचना संदर्भ संख्या स्था. IV/038/2021 दिनांक 23-08-2021 के तहत अधिसूचित) में से 149 आवेदकों ने जवाब दिया और 22 आवेदकों ने जवाब नहीं दिया। 10 नए आवेदकों के आवेदन प्राप्त हुए। परिणामस्वरूप, समिति द्वारा कुल 181 आवेदनों (अनुलग्नक-II) पर विचार किया गया।

11. समिति ने आवेदकों द्वारा प्रदान की गई अद्यतन जानकारी के आधार पर कुल वेटेज अंक की गणना के लिए अंक प्रदान किए हैं।

12. आर्थिक रूप से पिछड़े वर्ग और/या अन्य पिछड़ा वर्ग के नोन-क्रीमी लेयर श्रेणी के तहत लाभ प्राप्त करने के लिए पात्र होने के लिए 8 लाख (पारिवारिक आय अथवा माता-पिता की आय के रूप में) की सीमा के अनुसार, समिति ने तय किया कि जिन मामलों में परिवार की कुल आय 8.00 लाख रुपये प्रति वर्ष से अधिक है ऐसे आवेदकों को आर्थिक रूप से अभावग्रस्त नहीं माना गया है।

13. समिति ने उन आवेदकों के संबंध में अंकों की गणना नहीं की जो विश्वविद्यालय के भर्ती नियमों / विधियों / अध्यादेशों / डीओपीटी के निर्देशों के अनुसार 'अयोग्य' पाए गए। इनमें वे आवेदक भी शामिल हैं जिन्होंने निर्धारित प्रारूप में आवेदन नहीं किया।

14. समिति ने अपने समक्ष प्रस्तुत सभी मामलों पर विचार किया और नियमों/दिशानिर्देशों के आधार पर विस्तृत विचार-विमर्श/चर्चा के बाद आवेदकों की निम्न तीन सूचियों को अंतिम रूप दिया है:

14.1 77 उम्मीदवारों (अनुलग्नक-III) को योग्यता के क्रम में योग्यता अंक प्रदान किए गए,

14.2 91 उम्मीदवारों को भर्ती नियमों/दिशानिर्देशों के अनुसार 'अयोग्य' पाया गया और इसलिए योग्यता अंक प्रदान नहीं किए गए। 91 में से 22 आवेदकों ने नियत तारीख, यानी 17.09.2021 तक अद्यतन जानकारी के साथ जवाब नहीं दिया।

14.3 जिन 13 मामलों पर विचार नहीं किया गया, वे अंतिम तिथि 31.12.2020 के बाद की मृत्यु/चिकित्सीय अक्षमता के मामलों से संबंधित हैं, जिनमें क्रमांक 181 जिसके सेवांत लाभों को अंतिम रूप दिया जाना बाकी है, का एक मामला भी शामिल है।

15. उपरोक्त को ध्यान में रखते हुए, निम्नलिखित को भी सभी संबंधितों के ध्यान में लाया जाता है:

15.1 चूँकि, 31.12.2020 तक होने वाली मृत्यु / चिकित्सा विकलांगता के मामलों के संबंध में आवेदनों पर विचार किया गया है, उनके दावों को निपटारा / बंद माना जाएगा और वर्तमान चक्र के लिए इन नियुक्तियों के बाद आगे ऐसे आवेदनों पर विचार नहीं किया जाएगा।

15.2 आज की तिथि के अनुसार, उपरोक्त बिंदु संख्या 14.3 को छोड़कर, जमा किए गए सभी आवेदनों का एकमुश्त उपाय के रूप में मूल्यांकन किया गया है। भविष्य में मृतक आश्रित अनुकम्पा नियुक्ति पर नियम के अनुसार हर वर्ष होने वाली रिक्तियों के आधार पर विचार किया जाएगा। इसलिए 31.12.2020 के बाद होने वाली मृत्यु / चिकित्सा विकलांगता से संबंधित आवेदनों पर 31.12.2020 के बाद होने वाली रिक्तियों की संख्या के आधार पर ही विचार किया जाएगा।

NOTIFICATION

It is notified that the Committee constituted by the Competent Authority of the University of Delhi vide Notification No. Estab.II(i)/2021/51 dated 6th January, 2021 and Estab.II(i)/010/2021/01/1327 dated 10th June 2021 to examine the case(s) for appointment on compassionate ground has submitted its report. The Committee decided to take into consideration the cases of death/medical disability occurred upto 31.12.2020. As mandated in the rule for compassionate appointment, 48 posts can be identified to be filled by compassionate appointment as per the vacancy positions upto 31st Dec. 2020 and advertised by University vide Notification No. Estab.IV/290/2021 dated 23.02.2021. As per data available, there were 171 applicants for consideration for appointment under this category.

The Committee invited applications from these eligible candidates. Further, the notice inviting applications were also notified on the website to allow other eligible applicants falling in time span specified above till 17th September, 2021. The Committee examined the applications so received on the basis of following criteria:

1. The first application submitted by the applicant after the death of the employee is considered as the original applicant. Subsequent change of applicant has not been taken into consideration. The new applicant is treated as a time-barred case and thus merit points not awarded. However, the original application was considered as per the eligibility.
2. The eligibility conditions of age, dependency, educational qualifications etc. of the applicant is considered in accordance with the general rules viz. pension rules, establishment rules on the subject accordingly.
3. The dependency of the applicant on the deceased was considered as on the date of the death/disablement of the regular employee of the University. Accordingly, the son/daughter so considered should have been dependent on the date of death / disability.
4. In accordance with DOP&T's No.14014/02/2012-Estt(D) dated 25th February, 2015, the committee considered cases of married son as dependent on the deceased to take care of the dependent family member of the deceased in case the spouse of the deceased employee has not applied/not eligible.
5. The widowed / divorced daughter(s) were considered eligible only if she were the dependent family member of the deceased employee at the time of his / her death. However, the married daughter as on date has been considered **not dependent**.
6. In cases where no present dependent family member existed, i.e., the spouse also expired subsequently, and the children are not covered under the dependent family definition presently, the cases are not considered for recommendation.
7. In cases where the spouse is / was also in the regular service at the time of death of the employee, such family member are not considered as dependent family member.

8. In case, the dependent son of the deceased employee has also expired, the application of daughter-in-law is not considered when the applicant was not a declared dependent family member by the deceased employee in the service records.
9. To assess the applicant's financial destitution, the committee has devised a Point Based Merit System (PBMS) (Annexure-I) to award weightage points in accordance with the latest guidelines of the DoPT considering the notifications of various Govt. Departments like Deptt. of Posts, Ministry of IT, CBIC.
10. Out of 171 (notified on the University website vide Notification Ref. No. Etab.IV/038/2021 dated 23-08-2021, as per available office records), 149 applicants responded and 22 applicants did not respond and 10 new applications were received. As a result, total 181 cases (Annexure-II) were considered by the committee.
11. The committee has assigned marks for calculation of total weightage points based on the updated information provided by the applicant.
12. In accordance with the limit of 8 lakhs (as family income and for parental income) to be eligible to avail benefits under EWS and / or OBC Non-Creamy Layer category, the Committee resolved that the cases where overall income of the family is more than Rs. 8.00 lakh per annum the applicant has not been considered as financially destitute.
13. The committee did not calculate the marks in respect of the applicant(s) found 'not eligible' on the parameters prescribed in accordance with the Recruitment Rules/Statutes/Ordinances of the University / DoPT instructions including the applicants not responded as per the prescribed format.
14. The committee considered all the cases presented before it, and after detailed deliberations/discussions based on the rules/guidelines, finalized three lists of the applicants, as given below:
 - 14.1 77 candidates (Annexure-III) awarded merit points in order of merit,
 - 14.2 91 candidates found 'not eligible' in accordance with the Recruitment Rules/Guidelines and therefore merit points not awarded. Out of 91, 22 applicants did not respond with updated information by due date, i.e. 17.09.2021.
 - 14.3 The 13 cases not considered pertain to cases of death/medical disability after the cut-off date of 31.12.2020 including one case of S.No. 181 whose terminal benefits are yet to be finalised.
15. In view of the above, the following is also brought to the notice of all concerned:
 - 15.1 Since, the applications with respect to cases of death / medical disability occurring upto 31.12.2020 have been considered, their claims would be treated as settled / closed and shall not be considered further after these appointments for the current cycle are made.

- 15.2 As on date except as at Point No. 14.3 above, all the applications accumulated have been considered, as a one-time measure, for assessment. In future the compassionate appointment would be considered on the basis of vacancy occurring as per the norms. Therefore, applications with respect to cases of death / medical disability occurring after 31.12.2020 shall be considered for the vacancies occurring after 31.12.2020 as per the norms for calculation of number of appointments to be made on compassionate ground.
16. The above information and annexures are notified herewith for information of the stakeholders.

Related certificates to be obtained accordingly.

Important Notes:-

- (a) If any applicant found 'not eligible' on the parameters prescribed in DoPT instructions and/or in accordance with the Recruitment Rules/Ordinance/Statutes/Regulations of the University; (b) and also in cases where overall income of the family is more than 8 lakh per annum, the application(s) will not be considered further and no merit points/marks will be calculated for such candidate(s).
- If it is found at any stage that the candidate/dependent has given incomplete or blank information/entry in the application form/enclosures, 'Zero' marks will be awarded on such parameter(s). In addition, if the incomplete/blank entry results in inappropriate financial assessment viz. income, employment, etc. the candidature will be summarily rejected.
- Tie-breaking procedure:-
 - While applying 105 points scale parameters, if situation arises that some candidates secure equal marks in merit point the preference would be given to the widowed applicant.
 - Further, in case of tie again, the tie breaking factor can be per dependent available income i.e., total of first three financial parameters (Pension-annualized, total terminal benefits and annual income of earning members and income from property) divided by total number of dependents. The lesser the per dependent available income, the higher the rank amongst the applicants whose scores had a tie.
 - In case of tie even after applying the factor of per dependent available income, then the left-over service of the deceased. Applicants related to Government servant with higher left-over service would be considered over the one with lesser left-over service. In case of tie even then, the next factor can be No. of physically/mentally challenged dependents & unmarried daughter(s). In case of tie even then, the next factor will be age of the applicant, the elder applicant be given preference.
