3. Candidates will be shortlisted for Skill test/Interview based on the information provided by them in their online applications. They must ensure that such information is true. If at any subsequent stage or at the time of Test/Interview any information given by them or any claim made by them in their online applications is found to be false, their candidature will be liable to be rejected.
4. Calling a candidate for Interview/Skill Test merely indicates that it is felt that he/she with others may be suitable for the post and conveys no assurance whatsoever that he/she will be recommended or selected or his/her conditions specified in the application will be accepted.
5. The Institute reserves the right to restrict the number of candidates for Skill Test/interview to a reasonable limit on the basis of qualification, level and relevance of experience higher than the minimum prescribed in the advertisement and other academic achievements. The Institute also reserves the right of rejecting any or all the applications without assigning any reasons therefore.
6. The number of vacancies may be increased or decreased.
7. Applications will be summarily rejected if all the relevant certificates are not uploaded as per the instructions.
